RECOMMENDATION

That the JLMBC: (a) conduct plan year 2024 officer elections for Chairperson (Management), Vice-Chairperson (Labor), First Provisional Chair (Management), and Second Provisional Chair (Labor); and (b) note and file the proposed meetings schedule for calendar year 2024.

DISCUSSION

A. Election of Officers

The JLMBC conducts annual officer elections for its Chairperson, Vice-Chairperson, First Provisional Chairperson, and Second Provisional Chairperson positions. According to the JLMBC Bylaws (rev. 12/14/22) ("JLMBC Bylaws"), the positions of Chairperson, Vice-Chairperson, First Provisional Chairperson, and Second Provisional Chairperson shall be elected at the regular meeting held in December and shall alternate between City Employee Organizations ("Labor") and City Management ("Management"). For terms beginning in odd-numbered years, the policies provide that the Chairperson and First Provisional Chairperson shall be a Labor member and the Vice-Chairperson and Second Provisional Chairperson shall be a Management member, as illustrated in the following table:

JLMBC Officer Positions	Odd-Numbered Years	Even-Numbered Years
Chairperson	Labor	Management
Vice-Chairperson	Management	Labor
First Provisional Chairperson	Labor	Management
Second Provisional Chairperson	Management	Labor

Staff recommends that the JLMBC conduct 2024 officer elections for Chairperson (Management), Vice-Chairperson (Labor), First Provisional Chair (Management), and Second Provisional Chair (Labor). Officer changes become effective January 1, 2024.



B. Meeting Schedule for Calendar Year 2024

To assist the JLMBC in planning for upcoming meetings, staff is also providing a "meetings schedule" for calendar year 2024 (Attachment B). The meetings schedule includes:

- Procurement development and final vendor selection for life, disability, accidental death and dismemberment, and Health and Dependent Care account services.
- Potential request for proposals for Medical Plans and additional ad hoc committee reporting of related plan changes.
- Regular updates of the Human Resources Payroll (HRP) replacement.
- Updates from LIVEwell on the transition to a new wellness provider.
- Quarterly staffing reimbursements.
- Open Enrollment communications activities in August.
- A schedule of LAwell Program benefit service provider presentations over the course of the full year.

The JLMBC should note some meeting scheduling flexibility will be necessary to accommodate the adoption of the 2025 LAwell Program. The meetings schedule is, as always, subject to change based on JLMBC member availability and the ability to establish meeting quorums. JLMBC members should notify staff of any anticipated scheduling conflicts as soon as practical so timely adjustments to meeting calendars can be made. Scheduling updates will be provided through the monthly Projects & Activities Report.
